#### **I. Announcements**

Kate motioned to accept August minutes, Nikki seconded. Minutes passed unanimously.

#### **II. Discussion**

Trunk or Treat is to be re-scheduled for October 31, from 3-5pm. The PNR board requests use of the entire park at this time, as well as police direction for the event.

Registration for cars will be at the October meeting on the 12<sup>th</sup>, from 6:30-8pm and October 17, 10am-noon. There will be no costume prizes this year, but multiple car entry prizes. 9 prizes, three categories (1st,2nd,3rd each category) (scary, funny, creative)

Sommer will call Genosky's to ask. The PNR board will also provide popcorn and drinks instead of hot dogs to the participants, Nikki will check with her sister for a popcorn popper.

Fliers will have to go out, 70 spaces will be available for cars as before. After all registrations are complete, the # of kids participating will be texted to all registrants.
