**Residential Building Permits with UCC Inspections**

1. Residential New Homes - \$0.25 per square foot of living space
2. Residential Improvements/Renovations/Additions - \$50.00 for the first \$2,000.00, \$2.50. for each additional \$1,000.00
3. Sheds, Garages & Storage Buildings 1000 square feet to 1499 square feet - \$75.00
4. Sheds, Garages & Storage Buildings 1500 square feet and over - \$100.00
5. Retaining Walls 4 feet high and above - \$35.00
6. Residential & Commercial Roofing **if** more than 25% of roof - \$35.00
7. Prefabricated above ground Swimming Pools 2 feet deep or more - \$35.00
8. All In-Ground Swimming Pools - \$50.00
9. Spas & Hot Tubs - \$35.00
10. Decks 30 inches & above (covered &/or uncovered) - \$50.00
11. Fences 6 feet tall and over - \$35.00
12. UCC Fee as Required by Law - \$4.00 per each Building Permit
13. Wood Burning Stoves & Heaters - \$35.00

**Residential Inspection Fees (Current Inspector HMT & Assoc.)**

► *Inspections are on a case by case basis - subject to the rules & regulations of the UCC*

**Commercial Plan Review**

1. Plan review must be completed prior to the issuance of a commercial building permit by the Township's Engineer (Currently HMT & Assoc.) – Minimum \$300.00 payable in advance as dictated by the scope of the project

**Commercial / Industrial Building Permits with UCC Inspections**

1. Standard / Typical Business Building - \$200.00 minimum and \$0.50 per square foot
2. Complex / Complicated building - \$500.00 minimum and \$0.75 per square foot (schools, multi-story buildings, etc.)
3. Commercial Improvements/Renovations/Additions - \$75.00 for the first \$2,000.00, \$4.00 for each additional \$1,000.00
4. UCC Fee as Required by Law - \$4.00 per each Building Permit

**Commercial Inspection Fees (Current Inspector HMT & Assoc.)**

1. \$60.00 per hour / inspection based on the Building Code Officials (BCO) estimate

► If re-inspections are required due to deficiencies being found, additional fees will be incurred at a rate of \$60.00 per hour / inspection

**Extension Fees for Building & Zoning Permits ( 1 one time extension of original permit for 6 months )**

1. Residential Extension Fee - \$25.00
2. Commercial Extension Fee - \$50.00

**Zoning Permits (no inspections required)**

1. Unattached Garages, Carports & Storage Buildings less than 500 square feet - \$35.00
2. Unattached Garages, Carports & Storage Buildings 500 sq. feet to 999 sq. feet - \$50.00
3. Agricultural Buildings less than 500 square feet - \$35.00
4. Agricultural Buildings 500 to 999 square feet - \$50.00
5. Agricultural Buildings 1000 to 1,499 square feet - \$75.00
6. Agricultural Buildings 1,500 square feet and up - \$100.00
7. Swimming Pools - permanent above ground **if less** than 2 feet deep - \$35.00
8. Decks (uncovered) under 30 inches off ground - \$35.00
9. Non-Structural repairs / alterations - \$35.00
10. Recreational Cabin Exclusion Form - \$15.00
11. Non-Conforming Structure/Use Registration - \$15.00 each

**Certified Zoning Letters:** \$25.00 per request

**Fireworks Permits**

1. \$35.00 plus \$500.00 Bond

**Animals**

1. Animal Impoundment Fee – Rate as assessed by the Animal Control Officer

**Exotic Wildlife Registration Fee**

1. Yearly registration fee - \$10.00 per Animal

**Residency Permits (not to be confused with occupancy permits)**

1. Rentals - \$10.00 with every new and/or change of rental occupancy

**Cell Phone Towers/Antennas**

1. Antenna co-habitation - \$500.00 each
2. Building Permit Fee - \$15.00 per Vertical Foot

**Demolition Permit Fee**

1. \$35.00 each

**Sign/Zoning Permits**

1. Signs that are 12 square feet or less - \$25.00 (Political signs are exempt but must be removed within 30 days of election)
2. Signs that are over 12 square feet, and under 75 square feet - \$50.00
3. Signs that are over 75 square, and under 150 square feet - \$75.00
4. Signs that are over 150 square feet to 300 square feet - \$100.00

**Wind Energy Systems, Small**

1. \$100.00 each

**Cancellation of Permits:**

1. Any approved Building Permit can be canceled up to 6 months following issuance - \$50.00 Cancellation Fee ***NO REFUND AFTER 6 MONTH DEADLINE***

**Grading, Filling, Excavating Permit per Cubic Yards with Inspection**

*\*A Surety bond of 50% of the estimated cost of construction is required on all projects of 30,000 cubic yds and above.*

*\*Inspections billed at the rate of \$70/hr. with an up front inspection fee of \$210 required.*

**Subdivision Plan Review**

1. Minor Subdivision (1 – 2 Lots) - \$240.00 or actual cost incurred by the Township, whichever is greater.
2. Median Subdivision (3 or 4 lots) - \$320.00 or actual cost incurred by the Township, whichever is greater.
3. Major Subdivision (5 or more lots) - \$560.00 plus \$25.00 for each lot in excess of 6 lots or actual cost incurred by the Township, whichever is greater.
4. Mobile Home Park - \$560.00 or actual cost incurred by the Township, whichever is greater.
5. Site Plan Review - \$300.00 or actual cost incurred by the Township, whichever is greater.

**Mobile Home Removal Permits**

1. Each mobile home that is being removed from the township - \$35.00

**Buildings & Unsafe Structure Appeals\***

1. Residential- \$400.00 or actual cost incurred by the Township, whichever is greater
2. Others-\$500.00 or actual cost incurred by the Township, whichever is greater

**Conditional Use Application & Appeal Hearings\***

1. Residential - \$400.00 or actual cost incurred by the Township, whichever is greater.
2. Others - \$500.00 or actual cost incurred by the Township, whichever is greater.

**Uniform Construction Code Appeals\***

1. Residential - \$400.00 or actual cost incurred by the Township, whichever is greater.
2. Others - \$500.00 or actual cost incurred by the Township, whichever is greater.

**Zoning Variance Appeals\***

1. Residential - \$400.00 or actual cost incurred by the Township, whichever is greater.
2. Others - \$500.00 or actual cost incurred by the Township, whichever is greater.

**Re-zoning Application & Appeal Hearings\***

1. \$1,000 or actual cost incurred by the Township, whichever is greater.

### Curative Amendment Application\*

1. \$2,500 or actual cost incurred by the Township, whichever is greater.

*\* Administrative costs of Township employees to be charged at \$25.00 per hour for each type of Appeal Hearing \**

1. \$30.00 each hardcopy if picked up at the Township building
2. \$35.00 each hardcopy if mailed to recipient (payment must be made in full prior to shipping)
3. \$5.00 each CD (ZO & SALDO on one) if picked up at the Township building
4. \$10.00 each CD if mailed to recipient (payment must be made in full prior to shipping)
5. \$5.00 each color Zoning Map, if larger than a 8.5x11 (Shipping \$2.00 extra)
6. \$3.00 each black & white map. If larger than a 8.5 x11 (Shipping \$2.00 extra)

### Holding Tanks

1. Application Fee – Paid directly to the Washington County Sewage Council (WCSC)
2. Administration Fee (non-refundable) - \$100.00

3. Escrow Account (**Separate Check**) – 10% of the total cost of the unit plus installation (in the form of a personal check or security bond)
4. Annual Renewal Permit Fee - \$25.00

### **Sewage Complaint Procedures**

1. \$100.00 Washington County Sewage Council fee due at time of complaint filing (refundable if actual malfunction confirmed by WCSC)

### **Road Bond Permits**

#### *Types 1 & 2 Road Bond Amounts :*

1. Unpaved Township Roads- \$6,000.00/ mile
2. Paved Township Roads- \$12,500.00/mile
3. Paved to revert to a lesser condition - \$50,000.00/mile

#### *Type 3 Road Bond Amount:*

1. \$10,000.00 for all municipal roads (lightly traveled)

#### *Application Fee:*

2. \$75.00 for each permit issued

### **Blanket Road Bond Permit**

1. \$100.00 Application Fee
2. Bond amount minimum \$500,000.00 *To be handled on as case-by-case basis.*

### **Driveway Permit**

- a. **Residential** - \$15.00 Application Fee  
    \$25.00 Permit Fee (includes site measuring & inspection)  
    **\$40.00 Total Fee**

### **Road Encroachments**

- a. **Residential** - \$15.00 Application Fee

### **Surface Openings – *IN ADDITION TO THE ENCROACHMENT FEES***

1. Opening in Pavement 36 feet & over- \$ 55.00
2. Opening in Pavement & Shoulder 36 feet & over- \$55.00
3. Opening in Pavement less than 36 sq ft.- \$40.00
4. Opening in Shoulder less than 36 sq ft.-\$30.00

Opening Outside Pavement & Shoulder-\$25.00 (if occupies 2 or more streets higher price charged.)

**Utilities – *IN ADDITION TO THE ENCROACHMENT FEES***

1. Crossings- \$100.00 (examples-overhead triples, conveyors or pedestrian walk-ways)
2. Above Ground Utilities- \$50.00
3. Additional Above Ground Connection Facilities-\$5.00

**Road Encroachment / Road Bond / Driveway / Misc.**

1. Extension Fee- \$50.00 (One time 6 month maximum extension – includes 1 inspection)
2. Cancellation Fee - \$25.00 (a one time cancellation of a road encroachment permit if not used and cancelled within 6 months of issuance)

**Inspection Fees – *FOR ANY PERMIT AS DEEMED NECESSARY***

\$25.00 per inspection – Billed in 1 (one) hour increments.

**New Address Requests**

1. Per address requested - \$25.00

**Junkyards & Junk Dealers**

1. Transfer of License- \$100.00
2. New License Fee- \$100.00
3. License Yearly Renewal- \$100.00

**Solid Waste Hauler**

1. Haulers Yearly License Fee- \$100.00 (If re-instituted by the State at a later date)

**Solicitations for Profit:**

1. Per person traveling on foot - \$15.00
2. Per vehicle (includes 1 person) - \$25.00
3. Per vehicle each additional person - \$15.00 each

**Records Request (Sunshine Act)**

1. Actual cost of duplicating the record per schedule of cost below *\*prepayment if \$100.00 or more\**
2. If documents are requested to be mailed, all costs off postage shall be assessed
3. Records NOT part of the Sunshine Act (as in personnel files) \$25.00 plus shipping costs

**Taxation** (*Fees to be retained by the Tax Collector*)

1. Tax Collector Certification Letters - \$15.00
2. Tax Collector Tax Duplicate Bill - \$5.00

**Attorney Fees**

1. Refer to Ordinance Codification Chapter 89, Article 1, for a complete breakdown of costs
