Collects Mt. Pleasant Township & Fort Cherry School District Real Estate Taxes

Township taxes are mailed out each year on March 15th. Taxes may be paid at discount by May 15th, face until July 15th, and are due at penalty after July 15th. Property owners who live near street lights and/or hydrants are also assessed for these utilities. This assessment is added onto the township bill.

Fort Cherry School taxes are mailed out each year on August 15th. Taxes may be paid at discount by Oct. 15th, face until Dec. 15th, and are due at penalty after Dec. 15th. School taxes may be paid in three equal installments. Please refer to your school tax bill for the installment amounts, as well as the due dates. The Fort Cherry School District also assesses a per capita tax. This is a \$10.00 tax which is assessed for any resident, 18 years of age and over, who resides in the school district. There are no exemptions for this tax. The per capita tax is added onto the real estate tax bill, or is billed separately for renters or dependents.

Unpaid township & school taxes are turned over to the Washington County Tax Claim Bureau by January 15th of the following year. Taxpayers must then make arrangements with the County for payment. Any unpaid light & hydrant assessments are turned over to an independent collection agency.

Payments may be mailed to the tax collector at 4 Kelley Lane, Hickory, PA 15340, or paid in person. Normal officer hours are Saturday's 9am – 11am during March 20 - May15, 2010 and August 21 - Dec.18, 2010. Special hours are 5:30pm - 7pm on May 4,6,11, & 13, 2010 and Oct. 5,7,12, & 15, 2010. All other hours are made by appointment. Please refer to your tax bill for those special hours. There are no scheduled office hours from Jan. 15th - March 15th. If you would like to pay in person during that time, please call the tax collector to make arrangements. All office hours are held at the township office located at 31 McCarrell Road, Hickory, PA. Payments may also be dropped off during the week, during regular business hours, and will be held there for the tax collector. Preferred methods of payment are either personal check or money order. Checks should be made payable to Jamie L. Torboli, Tax Collector. If payment must be made in cash they can only be made directly to me either during my office hours or by special arrangement. Please be advised that you can NOT make cash payments at the township office in my absence.

Mortgage companies or closing agencies may request a three year tax certification by mailing their request to the tax collector. There is a \$15.00 charge for this service. The check should be made payable to Jamie L. Torboli. There is no charge for current tax information.
