A RESOLUTION OF THE BOARD OF SUPERVISORS OF MOUNT PLEASANT TOWNSHIP, WASHINGTON COUNTY, COMMONWEALTH OF PENNSYLVANIA, APPOINTING A DELEGATE AND ALTERNATE DELEGATE TO THE WASHINGTON COUNTY TAX COLLECTION COMMITTEE.

WHEREAS, Act 32 of 2008 established a requirement for Countywide Collection of Earned Income Taxes, with the option of other 511 taxes, and

WHEREAS, each political subdivision must appoint a delegate, to vote on its behalf and appoint an alternate who may vote if the delegate is not available.

WHEREAS, the individuals selected to represent Mount Pleasant Township must be knowledgeable of the Earned Income Tax process and represent the Township to promote a collection process that is efficient and professional.

NOW, THEREFORE, be it resolved that the Mount Pleasant Township Board of Supervisors appoints Darla Protch, Township Manager as its delegate and Donald Reed Sr., Supervisor as the alternate delegate to represent the municipality. Said individuals will represent the Township until replaced by the Board of Supervisors.
