

**TOWNSHIP OF MOUNT PLEASANT  
WASHINGTON COUNTY, PENNSYLVANIA  
RESOLUTION NO. 2021-4**

WHEREAS, Chapter 168 (§168-5.A(2)) authorizes the Board of Supervisors to adopt a Resolution establishing a Fee Schedule for Residential Garbage Fees (annual, quarterly, or monthly) to be assessed to residential property owner(s) for providing residential garbage collection, removal and disposal services;

WHEREAS, based on the cost of the Township's current contract for Solid Waste services, and related billing and administrative costs, the Board of Supervisors has determined that it shall be necessary to set the Fee for collection of garbage and rubbish removal services, effective January 1, 2021, and thereafter until modified by further resolution, at **\$52.00 per quarter**, per each residence/dwelling unit, subject to a Senior Discount for eligible Property Owners and a Farm/Small Business exemption for eligible Property Owners, as provided herein, which fees shall be invoiced to the resident on a quarterly basis as set forth herein;


NOW, THEREFORE, be it resolved by the Board of Supervisors of Mont Pleasant Township, Washington County, Pennsylvania, as follows:

- I. **Quarterly Residential Rate:** That, commencing January 1, 2021, and thereafter until modified by further Resolution of the Board of Supervisors, a quarterly Fee for the collection, removal and disposal of residential garbage and rubbish, and related costs, shall be assessed against the Property Owner(s) of each private residential dwelling unit located within the Township, in the amount of **\$52.00 per quarter**, which Fee shall be billed quarterly to each Property Owner, on or about January 15<sup>th</sup>, April 15<sup>th</sup>, July 15<sup>th</sup> and October 15<sup>th</sup>, and shall be due and payable within 30 days of the date of invoice. All unpaid, past due balances shall be subject to a Penalty/Interest charge at the rate of 10% per annum.
- II. **Senior Discount:** Property Owners who are at least 62 years of age are eligible to obtain a 10% discount upon proof of age.
- III. **Farm/Small Business Exemption:** Eligible family farms and other small businesses lawfully operating on the same property on which the farmer or business owner/Property Owner(s) resides may obtain an exemption from participation in residential garbage service by submitting a letter request directly to the Township Manager, along with appropriate documentation verifying the operation of a lawful farm or small business on the property along with written proof that the farm or business utilizes private refuse removal services that are also utilized by the residential dwelling unit(s) located on the farm or property.
