

**MOUNT PLEASANT TOWNSHIP**  
**Board of Supervisors**  
**Meeting Minutes**  
**September 28, 2022**

- Call to Order:** Chairman Gary Farner called the regular monthly meeting of the Board of Supervisors to order at 7:00 p.m. The Pledge of Allegiance was recited.
- Public Discussion:** None.
- Approval of Minutes:** The minutes from the August 24, 2022 Supervisor's Meeting were presented. A motion was made by Gary Farner to approve these minutes, second by Shane Maga, M/C.
- Departmental Reports:** A motion was made by George Rice, second by Shane Maga to approve all of the Departmental Reports, M/C.
- Payroll & Bills:** A motion was made by Shane Maga, second by Gary Farner to authorize/ratify the payment of bills and payroll for the month of September 2022, M/C.
- Trunk or Treat:** A motion to approve Trunk or Treat for Saturday, October 29<sup>th</sup> from 12 to 2 and the issuing of a \$500.00 check for prizes was made by Gary Farner, second by Shane Maga, M/C.
- Part-time Firefighter:** George Rice made a motion to approve the hiring of Ryan Johnston as a part-time firefighter effective 9/2/2022, second by Shane Maga, M/C.
- Officer Resignation:** A motion was made by Shane Maga, second by George Rice to accept the resignation of Officer Tyler Drusbasky effective 9/10/2022, M/C.
- Full-time Officer:** A motion was made by Gary Farner, second by Shane Maga to approve the hiring of Crystal Metalik as a full-time officer effective 9/12/2022, M/C.
- Firefighter Resignation:** Gary Farner made a motion to accept the resignation of Thomas Riggan as a full-time firefighter effective 10/2/2022, second by Shane Maga, M/C.
- Resolution 2022-P:** A motion to adopt Resolution 2022-P amending Act 57 of 2022 was made by Gary Farner, second by George Rice, M/C.
- Ordinance No. 160:** A motion to adopt Ordinance No. 160 for the Uniform Pension Plan was made by Gary Farner, second by George Rice, M/C.
- Del. Fire-Hydrant:** George Rice made motion, second by Shane Maga to authorize Jordan Tax Services, Inc. to perform delinquent Fire Hydrant-Light Assessment collection services commencing in January 2023, and to provide notice of non-renewal of existing Creditech Agreement effective 12/31/2022, M/C.

**Budget Meetings:** A motion to advertise budget meetings for October 6<sup>th</sup> and October 20<sup>th</sup> at 2pm and November 9<sup>th</sup> at 6pm was made by Shane Maga, second by Gary Farner, M/C.

**Full-time Firefighter:** Shane Maga made motion to advertise for a full-time firefighter, second by George Rice, M/C.

**Discussion Items:** Stacy Miller of 259 McCarrell Road was present to ask that the stop sign be replaced at Red Fox and McCarrell and also complained about speeding on McCarrell. Chris Lauff of 317 Fort Cherry Road along with Mark Wolfe of 283 Fort Cherry Road, Mrs. Kasmirsky of 321 Fort Cherry Road and Anita Steigerwall of 311 Fort Cherry Road were present to discuss a release of odor on August 1, 2022. They are concerned about air quality and feel with need to have a monitor. They were also not pleased that they were not informed by company about the release and wanted to know if the company will be penalized. Janet Lauff also feels that we should use the funds given to us by the drilling companies (Act 13) to have air quality monitors. They also complained about the condition of Fort Cherry Road, which is a state road.
